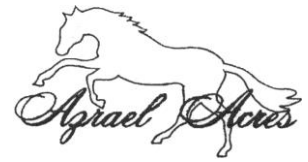

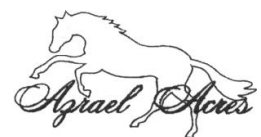
#### **RULES:**

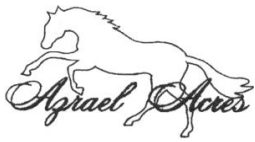
- Modified AHSA, USDF and USEA rules will be used as general guidelines.

- Approved headgear required at all time when riding. Safety vests required when jumping. Appropriate show attire required for Dressage Tests. Half Chaps and Paddock boots will be allowed for all riders.
- Refunds will only be given to riders who cancel before closing date and slot can be filled from a wait list. NO refunds or credits after closing date will be given. Closing date – Three days before event.

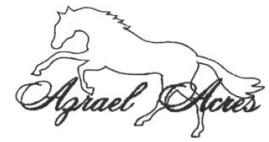
